Dear Mr. Reeves:

This office represents Visalia Police Department (the "Department"). Your California Public Records Act ("CPRA") request dated April 24, 2026 was forwarded to this office for review and response on May 5, 2026.

This letter responds to your request for records ("Request") pursuant to Government Code section 7920.000 *et seq.* This letter serves as a determination to your Request. Your Request is for the following:

**Request One:** System Access & Inter-Agency Sharing Logs: Any and all records, audit logs, or documentation showing access to data compiled by the Department via Flock Safety ALPR system by any agency other than the Department. This request includes, but is not limited to: Lists of "Hot List" hits shared with outside agencies, audit trails showing when outside agencies (federal, state, or local) queried the Department's Flock database, current lists of all agencies with whom the Department has a data-sharing agreement for ALPR data, the time frame for this request is from the initial installation/implementation of the Flock system to the present date.

**Request Two:** Specific License Plate Records: All records, images, and data points captured by the Department ALPR system (including fixed cameras and mobile units) that reference or identify the following California license plate (**JJRJR**). This request includes time stamps, location data (GPS coordinates or camera IDs), and associated photographs for every instance this plate was recorded from the time of system installation to the present date.

In accordance with Government Code section 7922.525, the Department has identified records that appear to respond to your request, in part or in whole.
